102.9 TOPEKA CAT COUNTRY'S "REMOTE DRAWING" CONTEST OFFICIAL RULES

Eligibility. Limit one (1) entry per person per day. All entries must be received by the **deadline stated at the remote broadcast on September 15, 2022**.

Winner Selection. On or about 1:00pm on September 15, 2022, Station will select five (5) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the telephone number provided with the entry or via PA system announcement and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification will result in disqualification.
