TOPEKA'S NEW 102.9 CAT COUNTRY'S "STAMPEDE NIGHT TICKET GIVEAWAY" OFFICIAL RULES

The Station will conduct the **TOPEKA'S NEW 102.9 CAT COUNTRY's "STAMPEDE NIGHT TICKET GIVEAWAY"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. - 2. **Contest Period.** The Contest entry period will begin at 6:00pm CST on June 24, 2023, and will run through 8:00pm CST on June 24, 2023. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

 - Remote Broadcast: Attend a remote broadcast conducted by Station on June 24, 2023 from 6:00pm through 8:00pm at High Tide 21, 10772 Perry Park Dr, Perry, KS 66073 and complete an entry form. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.
- 4. **Winner Selection.** On or about every fifteen (15) minutes on June 24, 2023, Station will [select one (1)] winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant(s) [must be present to win and will be contacted] using the telephone number provided with the entry or via PA system announcement and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner(s) are final and

binding in all matters related to the Contest. Failure to respond to the initial verification will result in disqualification.

- 5. Verification of Potential Winner.
