## TOPEKA'S NEW 102.9 CAT COUNTRY'S "STAMPEDE NIGHT TICKET GIVEAWAY" OFFICIAL RULES

The Station will conduct the **TOPEKA'S NEW 102.9 CAT COUNTRY'S "STAMPEDE NIGHT TICKET GIVEAWAY"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

## 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, plus residents in the following Kansas counties are also eligible: Atchison, Leavenworth Douglas and Franklin, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. **Contest Period.** The Contest entry period will begin at 5:00pm CST on July 10, 2023, and will run through 7:00pm CST on July 10, 2023. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

**Remote Broadcast**: Attend a remote broadcast conducted by Station on July 10, 2023 from 5:00pm through 7:00pm at Red Robin, 6230 SW 6th St, Topeka, KS 66615 and complete an entry form. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.

4. **Winner Selection.** On or about every fifteen (15) minutes on July 10, 2023, Station will [select one (1)] winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant(s) [must be present to win and will be contacted] via text message using the telephone number provided with the entry or via PA system announcement and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner(s) are final and binding in all matters related to the Contest. Failure to respond to the initial verification will result in disqualification.

- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. The approximate retail value ("ARV") of prize (b) is TWO HUNDRED NINETY-EIGHT DOLLARS (\$298).

TOTAL ARV OF ALL CONTEST PRIZES IS: ONE THOUSAND SIX HUNDRED NINETY-EIGHT DOLLARS (\$1,698).

- 7. Entry Conditions and Release.
