TOPEKA'S NEW 102.9 CAT COUNTRY'S "REMOTE DRAWING CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KTOP-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.topekacatcountry.com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **TOPEKA'S NEW 102.9 CAT COUNTRY's "REMOTE DRAWING"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, plus residents in the following Kansas counties are also eligible: Atchison, Leavenworth Douglas and Franklin, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days. - 2. **Contest Period.** The Contest entry period will begin at 11:00am CST on September 30, 2023, and will run through 1:00pm CST on September 30, 2023. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**
 - Remote Broadcast: Attend a remote broadcast conducted by Station on September 30, 2023 from 11:00am through 1:00pm at Furniture Mall of Kansas Outlet, 140 SE Jefferson St, Topeka, KS 66607 and complete an entry form. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.
- 4. **Winner Selection.** On or about 10:00am on October 3, 2023, Station will select one (1) winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant(s) will be contacted using the telephone number provided with the entry or via PA system announcement and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner(s) are final and binding in all matters related to the Contest. Failure to respond to the initial verification will result in disqualification.

- 5.
