TOPEKA'S NEW 102.9 CAT COUNTRY'S "DRAGON TRIVIA" CONTEST OFFICIAL RULES

The Station will conduct the **TOPEKA'S NEW 102.9 CAT COUNTRY's "DRAGON TRIVIA"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - (b) Comment on the daily contest post pertaining to the Dragon Trivia Contest Post; and
- (c) Include in the comment: [the best guess to the answer to the daily] question

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by Facebook will be deemed not entered in the Contest.

This Contest is in no way sponsored, endorsed, administered by, or associated with Facebook. By submission of an entry, an entrant releases Facebook from any responsibility or liability for the Contest's administration, prizes, or promotion. An entrant is providing entry information to the Station and not to Facebook.

- 4. **Grand Prize Winner Selection.** [On or about 10:00 a.m. on June 16, 2025], Station will select one (1) Grand Prize winner in a random drawing from among all qualifying winners awarded by the station. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry Each winning entrant will be contacted using the telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize

The approximate retail value ("ARV") of prize (a) is THIRTY DOLLARS (\$30).

The approximate retail value ("ARV") of prize (b) is ONE HUNDRED SEVENTY-FIVE DOLLARS (\$175).

TOTAL ARV OF ALL CONTEST PRIZES IS: FOUR HUNDRED SEVENTY-FIVE DOLLARS (\$475).
